A Tribute to Patrick Kennedy: Celebrating a Legacy of Advocacy and Inclusion

Since the early 1940s, members of the renowned Kennedy family have been some of the most ardent advocates for the rights and social inclusion of people with intellectual and developmental disabilities. Through their rnkvkccn"kp f wpeg."tgrwvc-tion, and sincere belief in civil rights, they've created organizations and enacted ng ikuncvkqp"vj cv"dgpgLvu" millions of Americans with developmental disabilities and their families.

In 1946, the Joseph P. Kennedy Foundation was established to enhance the quality of life and increase awareness of people with developmental disabilities. In 1961, the same year The Arc of Atlantic County was founded, John F. Kennedy organized the President's Committee on Mental Retardation. In 1968, Eunice Kennedy Shriver formed the Special Olympics, and in 1990 Ted Kennedy helped pass the Americans with Disabilities Act. And the list goes on.

On Wednesday, March 31, 2010 at our sixth annual Tribute Dinner and Silent Auction, The Arc of Atlantic County will honor the life and work of

yet another member of the Kennedy family who commits himself to promoting the rights and inclusion of people with developmental disabilities: U.S. Representative Patrick Kennedy.

Kennedy has served as a member of the House of Representatives from Rhode Island for 21 years—half of his life. He is a co-founder and a co-chair of the Congressional Down Syndrome Caucus, whose mission is to educate members of Congress and their staff about Down syndrome. Additionally, the Caucus supports legislative activities that would improve Down syndrome research, education and treatment; and promote public policies that would enhance the quality of life for those with Down syndrome.

Recently, Congressman Kennedy announced that he will not run for reelection after eight terms in congress. This will be vjg"Ltuv"vk o g"kp" o qtg"vjcp" 60 years that a member of the Kennedy family is not serving in Congress. This year's Tribute Dinner and Silent Auction offers our friends a unique opportunity to honor Patrick Kennedy and the mark that both he



and his family have made kp"vjg"Lgnf"qh" fgxgnqr o gptal disabilities as public servants, while also raising much-needed funds for The Arc's programs.

Achieving real choices: A Home of His Own

George Karrish, 50, began to dream of owning his own home when he was 18 years old. And not just any home, either. He hoped for a one-story, with a screened-in porch, not too big or too fancy. Perhaps in the country. A home with enough room to entertain his friends, and one that maybe someday he could share with a wife and family.

Years ago, having a developmental disability would likely have been a barrier to George ever reaching his dream. But through the support of a caring network of people including his family, friends and Arc staff coupled with his own personal commitment to his goals, George's dream of owning his own home came true on November 18, 2009 when he signed the contract on a three bedroom ranch home on a corner lot in Pleasantville.

"You don't know how good it feels to own something," George said on his settlement day.

George has received assistance through The Arc's Supportive Living program since he moved to Atlantic County in 2001 from another agency in order to be closer to his brother and parents. With the help of his job coach, George was almost immediately hired at a local nursing home in the maintenance department and has enjoyed work-

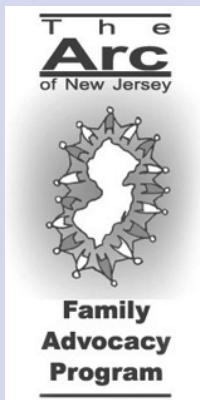
"I started working at Meadowview. Every other month I'd put money in my savings so I could build it up. Arc staff Renee Bird and Nichole Bonjean helped me with the realtor and looking at places, and the money situation. We had six eyes keeping aware of what was going on."

George loves the freedom to do what he wants to his home. He's going to a gym, and the other will be a guest bedroom. He's also eager to work in his yard when the weather gets warmer. "I'm going to plant a garden in the spring, maybe some broccoli, tomatoes and squash. I'd like to get a shed to keep all my tools. Maybe down the road I'll build a screened-in porch, too."

When asked what advice he'd give to other service recipients looking to own their own home, he had this to say: "Just keep working, saving your money, listen to advice from your friends and staff. Owning your own home is like heaven. You're more independent, more responsible and free. You don't have to listen to your landlords; you can do what you want."

Lending a Hand: Holiday Donors Respond in Record Numbers to Help Arc Families

When social services director Nicole Terzakis

kicked off The Arc's 2009 Holiday Partners program this past September, she wasn't optimistic. More families in need than ever before were signed up to receive food baskets and holiday gifts. The news reported daily on the ever-increasing unemployment rate in the region, and the response to her solicitation letters was slow. As the holidays loomed closer, she feared that she might not be able to match all 55 families—or more than 200 individuals—who were depending on The Arc and community donors to help them have a joyous holiday.

Through the help of the local media and an Arc email campaign, however, word about the Holiday Partners program spread. "Once the word iqv"qwv."yg"ygtg"lqqfgf"ykvj"fqpptu" adopting families, donating gifts and gift cards, and holding food and toy drives," says Terzakis. "I really thought this would be our worst year ever, and it turned out to be our most successful. We had a 42% increase in donors since last year."

In addition to many repeat donors, The Arc also welcomed a host of new supporters this year. Atlantic City's Hard Rock Café staff adopted a six-member, single-parent family from Atlantic City and treated them to a special holiday luncheon at their restaurant, where they presented them

with gifts and gift cards to grocery and department stores.

Maureen Gilbert from the Tkejctf"Uvqemvqp"Eqmngig"QhLeg"qh"vjg" Provost, which has adopted a family for several years, forwarded The Arc's email throughout the college, recruiting the school's softball, girls cross eqwpt{"cpf"lgnf"jqemg{"vgcou"cpf" the Social Work Club, all of which adopted a family.

School children also participated in the program, with students from the Marsh School in Absecon's second grade class donating four boxes of gifts, and Belhaven Middle School in Linwood continuing their support by adopting three families.

Many casino employees got involved this year as well, with the Borgata sales department adopting an Atlantic City family in lieu of a pollyanna. All four Harrah's properties par-

ticipated in a gift drive for several families. Other local participating businesses included Shore Memorial's Sterile Processing Department, the English Creek Lockheed Martin team, Yoga 9 owner Laurie Green and her patrons, Greg Petit of Hit and Run Sports, Harbor Pines Golf Club, Sea Oaks Golf Club, and the Gold Foundation.

Terzakis noted that these efforts make a world of a difference in the lives of the families who benefit. "These services are single-parent or single-income households. They struggle every day to make ends meet while caring for their loved ones, making the holidays extra stressful."

Linda Johnson, who works for the FAA, has been a Holiday Partner for years, choosing to donate to the same family each year. She has built a relationship with the family and delivers the gifts in person. "I have been very fortunate with all that I have received in my life, and I wanted to pass that appreciation forward to a family in need. I love what I do, and I hope that someday my current holiday partner will remember the joy she had during the holidays and sponsor a family when she is able. I encourage others to do the same!"
